The Index is designed to measure the performance of large and mid-cap stocks domiciled in developed Asia Pacific markets that pass rules-based screens for adherence to Shariah Investment Guidelines.

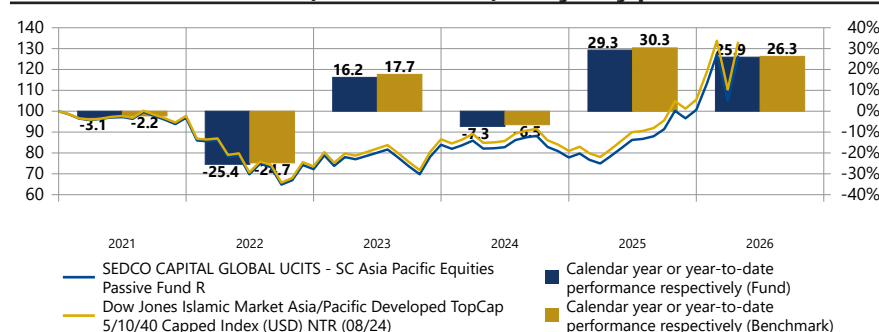

Net Performance in USD (rebased to 100) and yearly performance ¹⁾



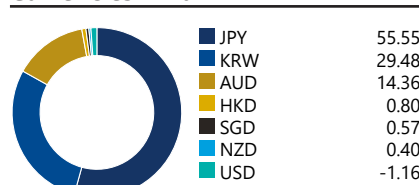

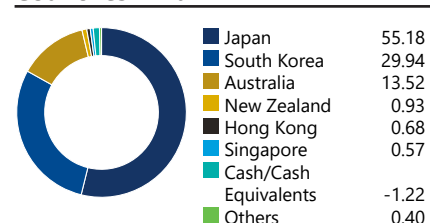

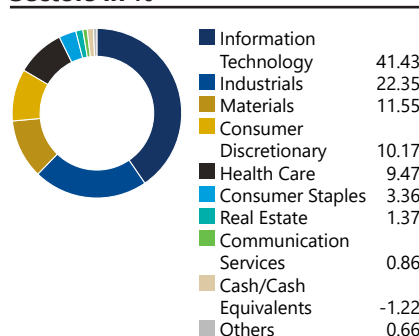
